

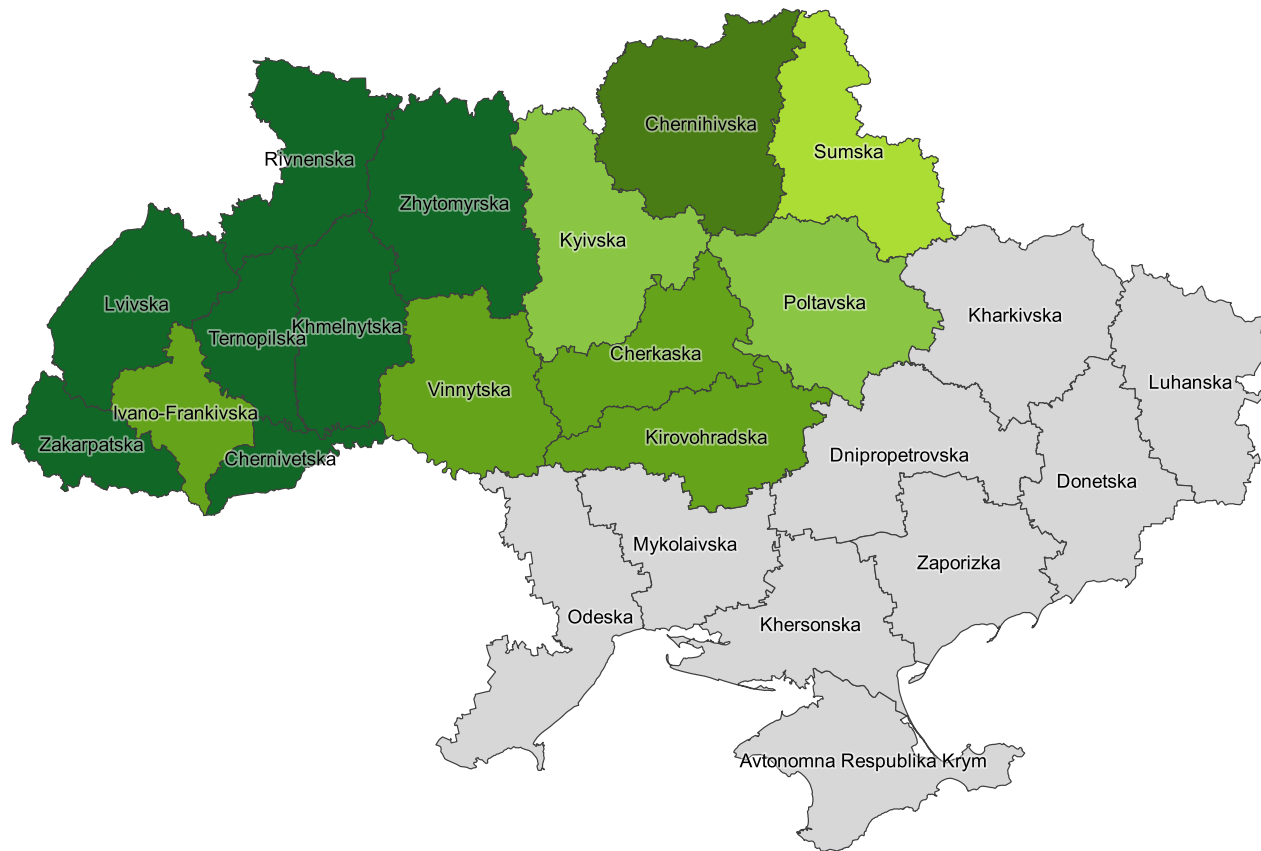

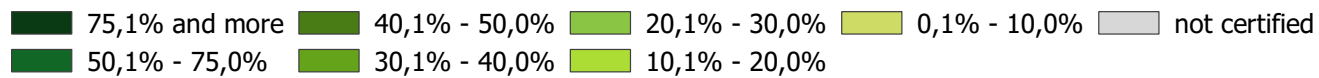

### Share of FSC-certified forest area

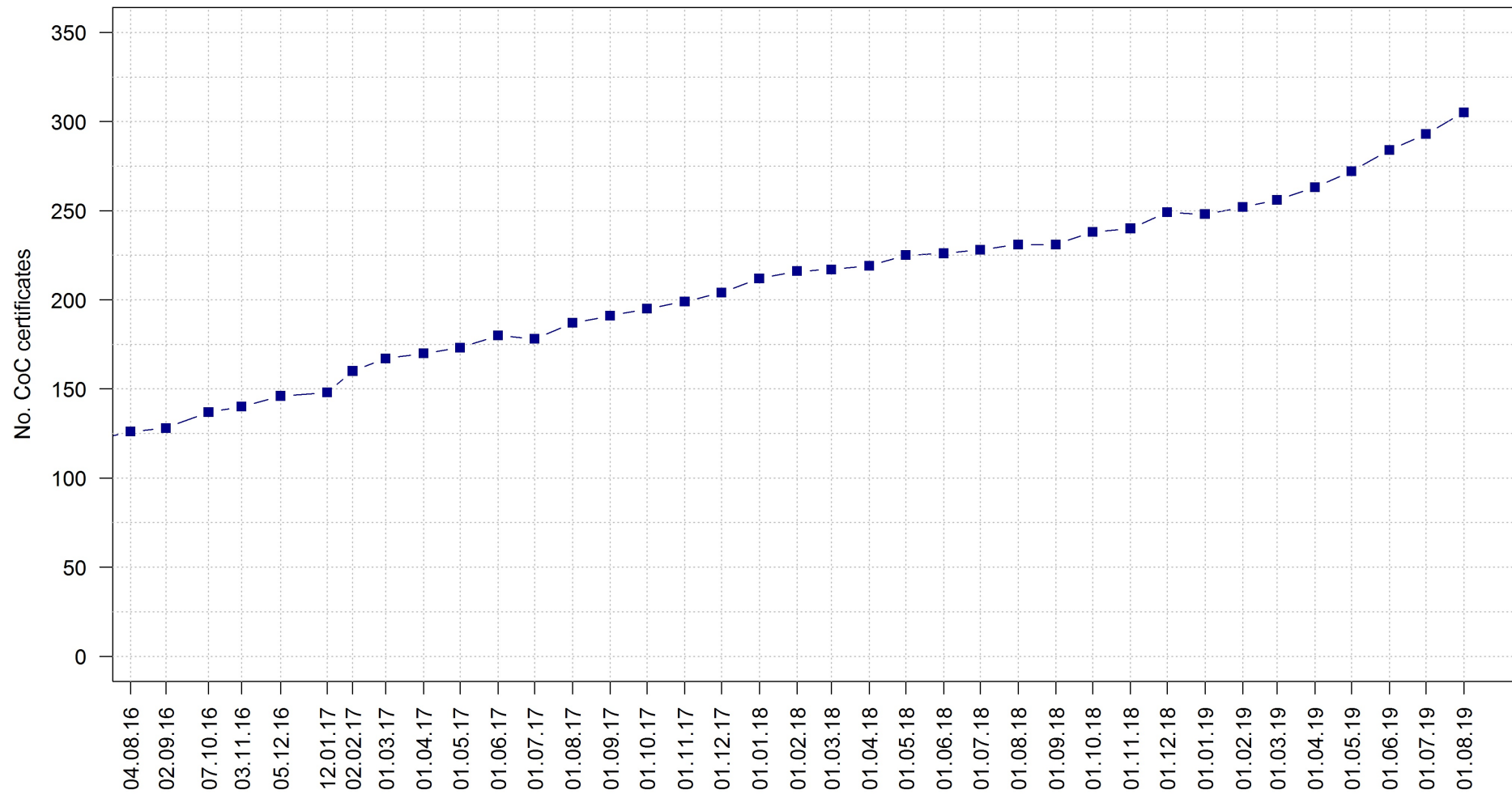

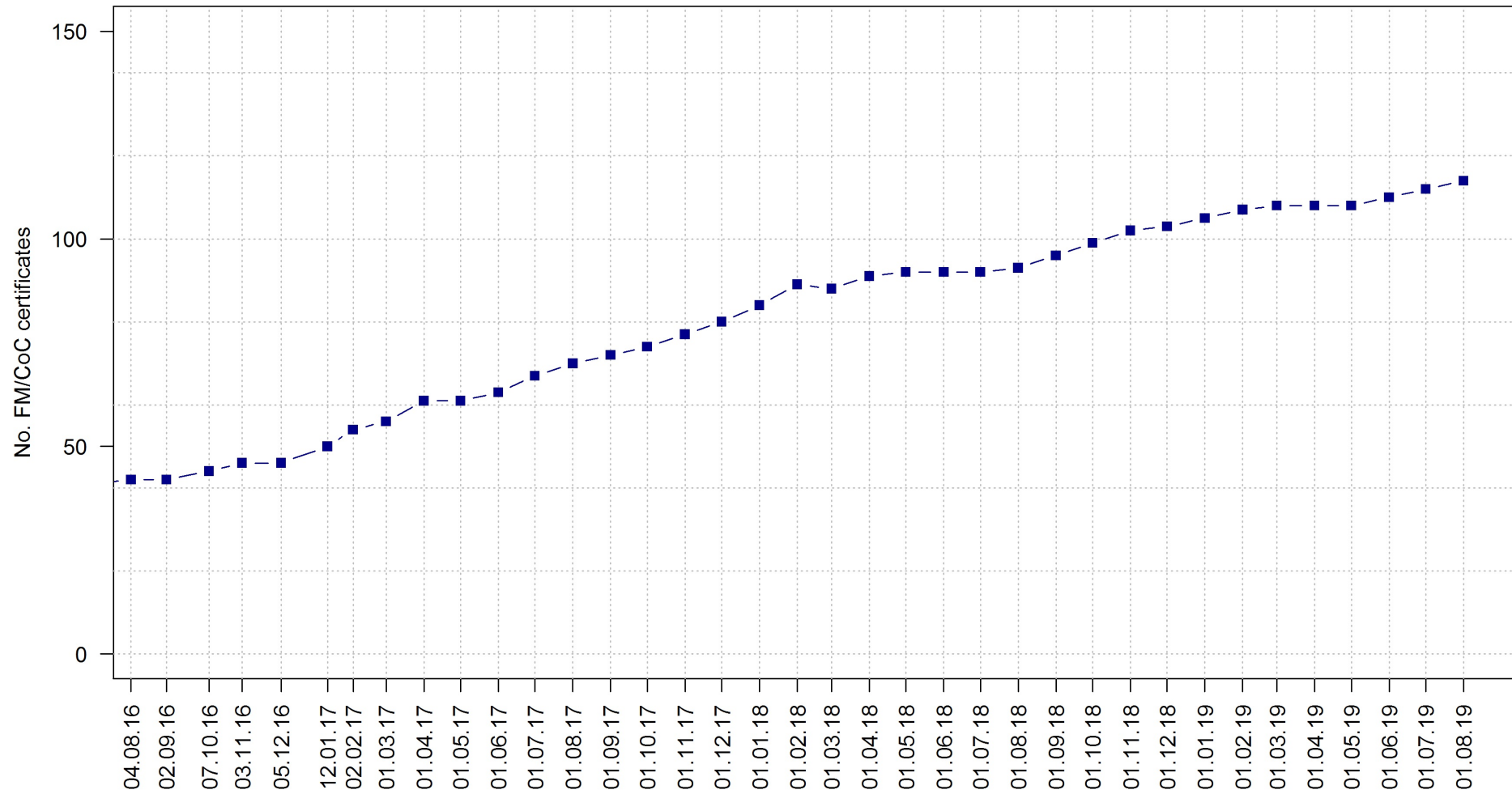

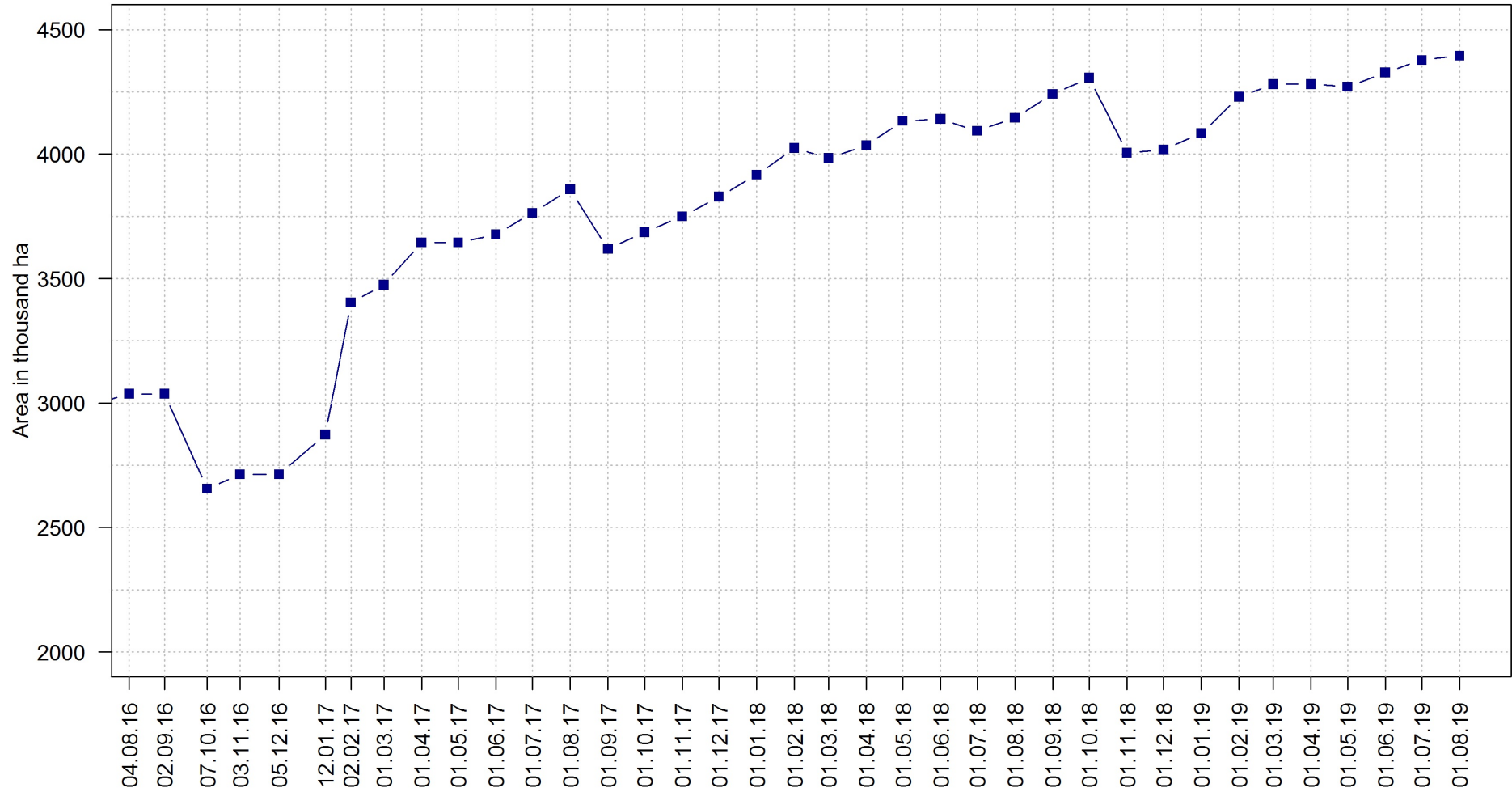
## CoC over time in Ukraine
